#### LIKELIHOOD OF ORGANIC AGRICULTURE - A REVIEW

Preface: Organic farming is to create the best possible relationship between the earth & men. This paper locates Indian experience in organic farming1. The farmers of India & China are known as the farmers of organic farming since history. It is definitely true that India had witnessed a tremendous growth in agricultural production in the era of green revolution. The technologies involved during the inception of green revolution supported by policies and further propelled by agrochemicals, machinery and irrigation were the main driving forces for the enhanced agricultural production and productivity5. Local demand for organic food is growing. India is poised for faster growth with growing domestic market. Organic agriculture is a system that relies on ecosystem management rather than external agricultural inputs and is found to be superior than conventional farming7. A major challenge today is certainly

#### **DID YOU KNOW?**

#### What is Tracenet?

Tracenet is an internet based electronic service offered by APEDA to the stakeholders for facilitating process certification for export of organic products from India which comply with the NPOP or NOP standards. After the registration of an individual operator's firm/company on Tracenet a unique user id and password is created which is shared with the operator.

# How is the final price of inspection and certification arrived at by a certification body?

An application form is sent to an operator along with the basic information kit. The application form has to be filled out and sent back to the certification body for assessment, after which the details of the final cost involved for inspection and certification is shared

#### How often is the inspection of a unit or farm conducted?

There is an annual inspection which is scheduled year on year. Aside, from which depending on the inspector's discretion there could be an unannounced inspection also.

#### What is an organic scope certificate?

A scope certificate is a certificate issued to an organic operation that complies with the organic standards defined. This certificate has a validity of one year and has to be renewed annually.

#### How is a scope certificate generated?

A scope certificate is generated on Tracenet software and is not manually done.

### After the scope certificate has been generated can the address or name be changed of the operator?

No, this cannot be done after the scope certificate has been generated. However, at the time of renewal the change in address or name can be made.

This farmer's name is Mr. Aravind and he is from a village namely Muttagi. This village is located in the district of Vijayapura. He has a lemon plantation spread over 18 acres of land. For the past 10 years, he has been growing lemons organically and has found that the yield is quite high. The annual turnover he gets from 2 acres of his lemon plantation amounts to about 7-8 lakhs of rupees. The inputs used on the plantation are Vermicompost and Cow dung among others. Mr. Aravind sells the lemons in the market and has found the quality of the lemons to be good. He believes that organic farming will help farmers reap profits at a low cost.
