# **Additional inspections**

If the operator is responsible for a necessary additional inspection due to major deficiencies (e.g. use of illicit means), ADITI will ask for additional fees. This will be calculated on the basis of the costs, thereby incurred (like daily rates for the inspector, travel costs, lab costs etc.)

**Remark:** Such additional inspections can be announced or unannounced. Announced additional inspections should not be mixed with "Unannounced Inspections" on a randomized basis as described in the next category.

### **Unannounced inspections**

ADITI will basically perform about 10% of unannounced inspections on a randomized base. ADITI does not charge for unannounced inspections but covers the connected operating expenses with the offer prices (for regular inspections).
