Subject: Immediate Update of ICS Manager & Contact Information, and Strengthening Grower Compliance Awareness

Dear Operators,

During a recent verification exercise, APEDA observed discrepancies while contacting certain grower groups. In several instances, the ICS Manager's name, contact number, or office address in the records did not match the current details, resulting in communication gaps.

To ensure transparency, compliance, and effective communication, all operators are hereby instructed to strictly adhere to the following:

1. Immediate Notification

Any change in the ICS Manager's name, contact number, or office address must be reported immediately to Aditi via email.

2. Accuracy of Records

Ensure that all information provided is current and accurate, as these details are used by APEDA, the Aditi, and other authorities for official correspondence and verification.

3. Operator's Responsibility

All changes must be communicated within 3 working days of taking effect. Failure to do so may lead to non-compliance observations during inspections or audits.

4. Submission Process

5. Strengthening Farmer Compliance Awareness

We strongly recommend that each ICS organise regular group meetings for registered growers/certified farmers.

- During these meetings, sensitise farmers on the importance of **honouring the**Farmer's Agreement they have signed, ensuring full compliance with all applicable

 NPOP Organic Standards in both letter and spirit.
- Emphasise that farmers who have signed the agreement must provide accurate and truthful information whenever interacting with any state-level officials or regulatory bodies.
- Maintain proper records of such meetings for inspection and verification purposes.

Your cooperation is essential to maintain compliance with the National Programme for Organic Production (NPOP) requirements, avoid operational disruptions, and strengthen the integrity of the certification system.
